

The following schedule of fines, costs and fees cover some civil infraction violations and applies to payments accepted within 10 days of the ticket being received by the 88th District Court - Montmorency County

**A \$10 default fee will be charged after 10 days if no admission is on file.**

The Driver Reinstatement Fee of \$45 may be added if your license has been suspended for failure to comply with judgment or failure to answer the ticket.

Payment Options: credit or debit card via phone,online or in person, cash, check, money order

**There will be a \$25 fee for all returned checks. No further checks will be accepted and payments must be made with cash, money order or credit card only. Failure to comply may result in a bench warrant for arrest and license sanctions. Criminal prosecution may also occur.**
